## 25 DAYS OF ATLANTIC GIVEAWAYS SWEEPSTAKES - OFFICIAL RULES

BY ENTERING OR OTHERWISE PARTICIPATING IN THE SWEEPSTAKES, ALL ENTRANTS AND OTHER PARTICIPANTS AGREE TO ABIDE BY THESE OFFICIAL RULES, WHICH ARE FINAL AND BINDING ON ALL MATTERS PERTAINING TO THIS SWEEPSTAKES.

After an Entrant completes the Entry form (the "Entry"), including selecting the Entrant's preferred performance date (the "Preferred Performance Date"), and submits the Entry, such Entrant will be entered
into the Sweepstakes for a chance to win. Each day beginning on the Start Date and continuing through December 9, 2023, Entrants are entered to win the applicable Prizes (defined below). Submitting one or more Entries will not increase the odds of winning the Prize. By participating in the Sweepstakes, each Entrant is confirming that they have read and agree to comply with: (i) these official rules; (ii) Atlantic's terms of use, located at http://atlanticrecords.com/terms-of-use/; (iii) Spotify's terms of use, located at https://www.spotify.com/us/legal/end-user-agreement/; (iv) ) Apple Music's terms of use located at https://www.apple.com/legal/internet-services/itunes/; and (v) all other Sweepstakes requirements. Additionally, by participating in the Sweepstakes, each Entrant is confirming that they have read and understand (i) Atlantic's privacy policy, located at http://atlanticrecords.com/privacy-policy/; (ii) Spotify's privacy policy located at https://www.spotify.com/us/legal/privacy-policy/; and (iii) Apple Music's privacy policy located at https://www.apple.com/legal/privacy/data/en/apple-music/. Joint entries are not accepted. Entrants may submit only one Entry. In the event of a dispute as to the origin of an Entry, the authorized account holder of the email address associated with the Entry will be deemed to be the Entrant. Each Potential Winner (defined below) may be required to show proof of being the authorized email address account holder, as determined by Sponsor in its sole discretion.

## 2. THE SWEEPSTAKES.

a. Determining the Winner. Sponsor will review all eligible Entries for conformity to the rules on each Sweepstakes Day. Within three (3) business days of each Sweepstakes Day, Sponsor and/or its designees will choose at random one (1) second prize winner for such Sweepstakes Day ("Daily Winners.)" As used herein, the term "Sweepstakes Day" shall mean each business day (i.e., each applicable Monday, Tuesday, Wednesday, Thursday, and Friday) which occurs during the Sweepstakes Period. Each Sweepstakes Day shall be an individual sweepstakes subject to the rules, terms, and conditions listed herein (each, a "Qualifying Sweepstakes"). A total of twenty-four (24) Potential Daily Winners will be selected. The Judges will again review all eligible Entries for conformity to the rules and on or about December 16, 2023, Judges will choose at random one (1) "Grand Prize Winner."
